3. The University will make surprise inspection to verify status of compliance. In case of non-compliance the University will take appropriate action against the College/ Institute.

7. When any vacant post will be filled by the College/Institute, University representative should be invited. Any appointments must be done in the presence of an University representative and norms of AICTE/ UGC/ University must be adhered. Vacant post of teaching and non-teaching positions must be filled up, within **forty-five (45) days** from the date of issue of this letter.
8. College/ Institute is requested to submit the residential address proof, Aadhar card along with mobile number of all teaching & non-teaching employee in case of any changes.
9. The College / Institute must to submit an affidavit that the land/ buildings for the courses have been demarcated exclusively for the purpose of course (name & intake) under Aryabhatta Knowledge University, Patna within **thirty (30) days** from the date of issue of this letter.
10. This extension of provisional affiliation will be subject to approval given by the State Government.
11. In the light of University notification vide letter no. 004/FIN/038/AKU/2014- 1323, dated 18/05/2020, the College/ Institute is directed to deposit the amount of Endowment fund in any nationalised / scheduled bank branch as Fixed Deposit (FD) in the name of college and thereafter the said FD will be pledge in favour of the Registrar, Aryabhatta Knowledge University.
12. If, Endowment Fee has not submitted within three months from the date of issue of this letter, no student shall be considered for registration and examination.
13. Failing the above terms & conditions, this letter will be automatically treated as withdrawn. In such case no further correspondence shall be entertained.

## Recommendation of the Inspection Team:-

The Inspection Team, duly constituted by Letter No. 006/Affili/771/AKU/2024 (Vol-II) - 3583 dated 22-07-2025 from Aryabhatta Knowledge University, Patna, visited **MSJ College of Professional Education**, Sandalpur, Bazar Samiti, P.O. – Mahendru, P.S. – Bahadurpur, Patna – 800006, Bihar, on 24-07-2025. The team inspected the infrastructural and instructional facilities available at the institution for the *Bachelor of Computer Applications (BCA)* and *Bachelor of Business Administration (BBA)* programmes, with an approved intake of 120 seats each, in connection with the grant of Provisional Affiliation for the academic session 2025–26.

## Observations & Findings:


Based on the information provided by the Director of the institute, the institution has been granted approval by AICTE, New Delhi. It was further observed that the institute is currently in the process of developing and enhancing its infrastructure to ensure the smooth implementation of the aforementioned programs. The inspected facilities appear to be in the stages of development, with scope for further expansion in the near future.

## Suggestions:

1. The management of the institution, **MSJ College of Professional Education**, Sandalpur, Bazar Samiti, P.O. – Mahendru, P.S. – Bahadurpur, Patna – 800006, Bihar, is advised to appoint faculty members in accordance with the cadre ratio prescribed in AICTE norms prior to the commencement of classes for the academic session 2025–26.
2. As per the norms of AKU and AICTE, it is advised that all infrastructural, instructional and basic amenities be completed, fully furnished and made functional prior to the commencement of classes for the academic session 2025–26.
3. Additional relevant books, journals, and e-journals must be made available in the library. Furthermore, the institute should obtain membership of the National Digital Library to enhance access to digital academic resources.
4. The computer lab and library should be established following AICTE norms, using a scientific and well-structured approach.
5. Provisions should be made to watch MOOCs courses through SWAYAM at the college.
6. Smart classes with digital boards are required. Wi-Fi facility is required to be more strengthened.
7. The institute campus should be clean, well-maintained and free from dust, while also ensuring greenery and an eco-friendly environment.

## Recommendations:

Based on the observations, findings, implementation of suggestions and the undertaking submitted by the Director of the institution, **provisional affiliation** may be granted to **MSJ College of Professional Education**, Sandalpur, Bazar Samiti, P.O. – Mahendru, P.S. – Bahadurpur, Patna – 800006, Bihar, for the **academic session 2025–26**. The affiliation may include the following courses with the specified seat capacities: **BCA – 120 seats and BBA – 120 seats**.
